### COMMITTEE REPORTS

Finance. Harry reported that after much back and forth, we do owe the IRS \$98 for underreported payroll in 2020. Because we changed payroll reporting systems midway through the year, \$550 was inadvertently not reported. Marcy asked about the Hotel/Motel Tax reporting for August – the \$2,665 on the Income Statement appears to be a total for both RVIC and DMO. Harry said he will check it.

Tourism. Charity reported that she is waiting to hear back from the company that is working on acquiring ads for our new tourist map.

Welcome Center. Marcy reported that the RVIC conference at Lake Lanier was productive for Titus. She will follow up with him to put some action plans in place, based on what he learned.

Signage. Kathleen Reed asked if she could be of any help in getting the last few Visitor Welcome Center signs put up. George and Marcy promised to handle before the next board meeting.

Public Art. William Back reported that he and Sue Gridley are still talking to artists.

Membership. George reported that the Dade County IDA and Trenton Pressing have invested. And we received an email today from EPB indicating that they will invest at the Champion level. Kathleen mentioned that she is talking to Don Marshall at Wilderness Outdoor Theater about membership and photos that were requested by Explore Georgia.

**DADE EXPO**

After much discussion about how we should manage refunds if the event must be cancelled due to COVID, Marcy moved and Dorinda seconded, that If the Dade Expo is cancelled, we will offer all vendors and sponsors a full refund; however, we will first ask if they are willing to consider their registration fee/sponsorship a donation to the Alliance. All board directors present approved.

The Facilities Agreement with the High School needs to be signed – George will follow up. In addition, George will ask if a vendor can park a truck outside to sell their custom-made items.

**JOB READY DADE**

George reported that he, Jane Dixon, William Back, and Evan Stone have been working to set up a hiring event on Saturday, September 25 from 9am to noon at the Dade High School. George moved that the board approve the Alliance to be a sponsor of the event; Harry seconded, and all board directors present approved. The Alliance’s participation will involve contacting companies to participate, sending info to our entire distribution list, developing a simple registration form, invoicing participating companies, and collecting payment. The IDA, Top of Georgia, and Evan Stone will cover costs associated with the set-up and publicity.

**OPEN FLOOR**

Bo Patterson attended the meeting and asked how she could help with the Dade Expo. She wants to assist with kids’ activities. Dena Abell is in charge of that and will contact Bo with how she can help.

Bo also asked if the Alliance would be interested in sponsoring a Scarecrow Contest on the Square in Trenton for the week leading up to Halloween. Beth Ann Biddle is willing to assist. The board is enthusiastic about the idea, and asked Bo to put a plan together and submit it at the next board meeting.

Jane Dixon asked if the Alliance should consider having a presence at the New Salem Festival. After discussion, the board agreed that we would not participate this year.

**MEETING SCHEDULE**

George said that he and Marcy would be out-of-town on the first Tuesday in October and asked if we could reschedule the next meeting. All agreed to Tuesday, September 28<sup>th</sup> at 6pm. The meeting will be available on Zoom and in person (location TBA).
