# **COMMITTEE REPORTS**

Committee reports were provided to all board directors prior to the meeting and are attached to these minutes. Marcy asked about the status of the Tourism Map being developed by the Tourism Committee. Charity, Chair of the Tourism Committee, was not present at the meeting, and George agreed to contact her for an update.

**DADE EXPO – Jolly Holidays!** Harry reported that the committee is moving along with plans. As of today, we have 52 paid exhibitors, 4 free non-profit organizations, and 7 sponsors for the event.

**Light Up Trenton.** Dena, Jane and Kathleen will be personally visiting all businesses along Hwys 11 and 136 to distribute the joint Light Up Trenton/Dade Expo flyers. They will encourage everyone to participate by decorating and they will encourage everyone to join the Alliance.

#### **OLD BUSINESS**

Insurance Policies. Marcy presented a proposal for insurance coverage for the Alliance to include General Liability, Special Events Liability, Business Property, Crime Coverage, and Management Liability. She will continue to work with Alfa to see if we can reduce the cost. Kathleen said that we should check with William Back to see if we can 'title' Board Directors differently within our Bylaws to avoid the need for Directors & Officers Liability insurance, and Marcy agreed talk to William. Marcy moved that the board approve up to \$1800 for insurance policies, Harry seconded, and all board directors present approved.

**Lunch & Learn.** Marcy reported that Scenic Dade Development Company has asked to be the presenter at the next Lunch & Learn in early 2022. They will talk about the Town Creek Trail project and their other initiatives. Marcy expressed some concern that the presentation would turn into a solicitation for donations. After discussion, Jane moved that we hold on approving them as a presenter and focus on a business issue instead. Dorinda seconded, and all board directors present approved.

### **NEW BUSINESS**

**Social Media Proposal**. Orey Yates expressed the need for the Alliance to expand its social media presence on Facebook, Twitter, Instagram and LinkedIn. He reported that the Dade County social media influence is huge – 37% of Dade County's population is following the county Facebook page. Orey has volunteered to assist with developing a robust, consistent social media approach. Marcy moved that the board appoint Orey as Committee Chair for Social Media. George seconded and all board directors present approved. Harry and Orey will meet to talk about what tools Orey will need to fulfill his role. Kathleen moved that the board approve \$50 per month for social media. George seconded and all board directors present approved.

**Update – Hotel/Motel Tax**. Marcy reported that she is working with county CFO Don Townsend to develop a flowchart for Short Term Vacation Rental properties to help them understand their responsibilities for business licensing and remittance of the 8% hotel/motel tax that state law requires. In July and August alone, Airbnb send check to the county for \$20,000 each month. The Alliance receives 43.75% of that amount – a significant new source of revenue for us.

**Georgia Chamber Membership Renewal**. Harry moved that the board approve \$500 to renew our membership in the Georgia Chamber of Commerce. Marcy seconded and all board directors present approved.

Committees and Chair contact information on website. Kathleen requested that we list all the Alliance Committees and the contact information for the Committee Chair on the Alliance website so that people might see an area of interest to them. Marcy expressed concern about posting email addresses on the website, as that could lead to excessive spam. We agree to list the Committees and Chairs and recommend that people call the Alliance to make contact.

**Dade County Ornaments**. Kathleen said that the Governor's Mansion has requested ornaments from around the state for the official Christmas tree. She would like to see the Alliance send four Dade Historical Society ornaments for the tree. Kathleen moved that the board approve the purchase of four ornaments (\$15 each) to send to the capitol. Jane seconded the motion, and all board directors present approved. Kathleen will contact the Governor's office to see if we can present the ornaments in person and we agreed to include Donna Street from the Historical Society in any such presentation.

Welcome Center – Thanksgiving week. Marcy said that Titus has requested a week of vacation November 21 - 27. We agreed that the Welcome Center will be closed on November 25, 26, 27, but we will try to find volunteers for Monday – Wednesday. Marcy will coordinate.

**Board Director Nominations**. Jane Dixon and Dorinda Moon served as the nominating committee. They presented the following four nominees to serve a three-year term, 2022-2024:

Harry Abell Dena Abell Kathleen Reed John Rollins

The nominees will be considered by the board and appointed at the next board meeting.

Marcy reminded everyone that:

- At the November board meeting, the nominating committee presents Board Director nominees to replace Directors rotating off the board.
- During the month of November, anyone interested in an Officer position shall notify the Secretary of the Board that he/she would like to be considered. The Chair and Vice-Chair must be Board Directors. The Secretary and Treasurer do NOT have to be a Director.
- At the **December** board meeting,
  - The Board shall confirm the Board Director nominees to a three-year term commencing January 1.
  - The Secretary shall present the names of those who have indicated that they are interested in serving in an Officer position. Those people shall have an opportunity to address the board as to why they would like to serve.
- At the January meeting, the new Board of Directors shall elect a Chair, Vice-Chair, Treasurer, and Secretary.

**Board Director Resignation.** Due to scheduling conflicts, Chad Payne has resigned from the Alliance Board of Directors. Per Article 3.4 of the Bylaws, Jane moved that the board appoint Stacey Prater to serve out the remainder of Chad's term through 2023. Marcy seconded, and all board directors present approved. Jane will contact Stacey.

# **OPEN FLOOR**

Marcy asked if the Alliance should be represented in the Dade County Christmas Parade. Kathleen will contact Selena, who is a member of a Mustang convertible club, to see if they will participate and allow us to decorate their cars as the Alliance. Kathleen will coordinate with other Alliance members to finalize plans.

#### TREASURER – Harry Abell

We have discovered an issue with how we were logging transactions in our accounting software. It will take some time to make the corrections, so there will be no Financial Reports for this meeting.

#### **WEBSITE** – Harry Abell

We had two major issues with our web site this month.

- One issue involved conflicts internal to the software on our site. This caused numerous emails to be sent to an administrator for the site. This was resolved by Harry.
- The second issue also involved numerous emails being generated via our Contact Us form. Someone in Norway and Russia produced hundreds of emails that were not legitimate. This issue was resolved by blocking all access to our site except to persons in the United States.

Harry renewed a license for \$24 for one of our software products.


#### **PUBLIC ART – Sue Gridley**

It is now being sent to ALL emails on our distribution list (603 active emails) so that potential investors will see some of the benefits of investing. But only INVESTORS will be featured in *Alliance Live!* and in articles and event announcements.

Our average Open Rate for Alliance Builder is 28%, which exceeds the average non-profit open rate of 25.5%
