COMMITTEE REPORTS

Provided to all Directors in advance and attached to these minutes. The following questions/comments were raised:

<u>Finance</u>. Marcy Williams requested that, in addition to the financial reports for the previous month, the Treasurer provide a year-to-date Income Statement each month.

<u>Membership</u>. Kathleen Reed has resigned her position as Chair of the Membership Committee and Chad Payne has agreed to step up to the position. Chad asked for everyone's help.

OLD BUSINESS

<u>Lunch & Learn Legislative Update – May 6.</u> Dena reported that everything is ready for the event on Thursday. The trustees will assist with set-up and clean-up. Dena requested help on Wednesday afternoon to decorate the room. We are expecting around 70 attendees.

<u>Dade Expo Update</u>. Minutes from the first committee meeting are attached to these minutes. Harry Abell envisions the Expo as a way to enhance, showcase and promote business in Dade County. A second committee meeting will be scheduled within the next 2 weeks. There are four other events scheduled for the same day that we are considering holding the Expo, so we will have to take that into consideration.

<u>Pro-Rating Investor Fees</u>. Kathleen Reed was unable to find any information about how other chambers in our area handle investor renewals. The board discussed various options. Marcy Williams moved, and Harry Abell seconded, that the expiration date for all Investors who joined in 2020 would be 12/31/2021 (as promised to those Investors), and annually thereafter on the 31st of December. The expiration date for all Investors who joined or will join in 2021 will be the anniversary date of their membership. All board directors present approved.

<u>Dade Sports Complex</u>. Dena Abell and Jane Dixon met with Stacy Stephens at the Dade Sports Complex and committed to help him with promoting the complex. Once the Lunch & Learn is over, they will move ahead with plans to visit area hotels to seek discounts for people attending events at the Sports Complex.

NEW BUSINESS

<u>Ribbon Cuttings – Procedure & Upcoming Events</u>. Jane Dixon reminded everyone of the three events this week – Guthrie's Grand Re-Opening, Canyon Gallery Grand Opening, and the Blessing Box dedication. Kathleen has created the agenda for the Blessing Box dedication and invited speakers.

The Celebration Event Procedure is attached to these minutes. Jane suggested that whichever Board Director helps sign up a new Investor, that director should follow-up with the Investor to ask how we can help them with their business and how the Alliance can better serve the community.

1945 Dade County Fair Update. Kathleen Reed is the liaison between the 1945 Fair and the Alliance. She said that there is a need for volunteers after the event to help with clean-up. George Williams asked if the Alliance should be a sponsor at some level for the fair. Harry Abell moved, and Kathleen Reed seconded, that the Alliance provide a sponsorship at the \$250 level. All Board Directors present approved.

<u>Investor of the Week</u>. Dena Abell had shared a photo from another chamber of a sandwich board sign that is placed in front of a "Member of the Week" business/organization. Marcy suggested that we use our existing sandwich board sign to do the same thing. The sign will be placed in front of the same business featured in our Alliance Live! video of the week.

<u>"How to Do" class.</u> Dena Abell reported that Josh Ingle had suggested that the Alliance host classes in areas such as carpentry, electricity, etc. The classes would be open to the public and there would be a fee to attend. The Board was interested in the idea and Dena and Jane will investigate further and report next month.

<u>In-person Board meetings</u>. George Williams polled the group to ascertain how everyone felt about starting to meet again in person. Several board members requested that no masks be required. Everyone was fine with the idea. George suggested that we meet in the conference room at the Dade Sports Complex and will talk to Stacy Stephens to set it up for our June meeting.
