COMMITTEE REPORTS

FINANCE - Harry Abell

FDIC: A new checking account with the Bank of Dade was opened with an initial deposit of \$100,000 (from CB&T). All recuring bills are now scheduled with Bank of Dade. The Bank of Dade can connect electronically to our bookkeeping software (Aplos) which makes preparing monthly reports much easier.

Credit Cards: We process credit and debit cards with a physical machine and using our website. I am cancelling the credit card machine for our Welcome Center. It costs \$10 a month and we rarely use it. We can use a virtual terminal for the few times we need to process a credit card. I will look into getting a Square account to make it easy to accept credit card payments when we are at events.

Plum Nelly: The Plum Nelly event is full. <u>Many</u> of the payments were made online, with one from our credit card machine from the registration form on our website.

Fees: The monthly charge for our bookkeeping and payroll system have increased from \$100 per month to \$180 per month. The rates for both services were raised. **COMMITTEE REPORTS**

PUBLIC ARTS – Sue Gridley

The Plum Nelly Depotsm Art Show registration is sold out with 26 artists. Sue asked board directors to please share Facebook posts on the Plum Nelly FB page. Costco and Ingles will donate food items to be sold at the show.

TOURISM – Charity Barton

Dan Zink, a member of the Tourism Committee, set up a meeting with Chris Atib, the Director of Partnerships with Chattanooga Tourism Company (formerly Chattanooga Convention and Visitor's Bureau). George Williams attended the meeting and reported that Chris wants to set up a follow-up meeting in Trenton to better understand all that Dade County has to offer.

The tourist maps are in development.

Dena Abell suggested that Charity talk to Jerry Wallace at Cloudland Canyon State Park and Mindy Haworth at the Dade County Library about events that they are jointly planning.

DRUGS DON'T WORK – Stacey Prater

MEMBERSHIP – Marcy Williams



OLD BUSINESS

Integer Volunteer Day. John Rollins is still looking for ideas for a project for 25-30 Environmental, Health & Safety people who will be visiting Integer's Trenton location on a weekday in October. They would like to do something for approximately two hours that would have a positive local impact – no trail work or trash pickup.

Job Fair. George reported that the DADE WORKS! Job Fair is scheduled for September 24 at DCHS. George, William Back and Evan Stone will be meeting soon to start planning. It was suggested that Alliance Investors should be able to participate for free.

October After-Hours Event. Possible name for the event is "Fright Night". Will Garrett has agreed to be one of the speakers – we are looking for two more people to talk about a difficult time they experienced in their business and how they overcame it. Nathan Wooten is a potential speaker and John Rollins will check at Integer to see if someone there can speak. Possible venues for the event include SLTC or the new event venue on Sand Mountain – Blackberry Ridge.

NEW BUSINESS

Smoke on the Square. This fundraiser for A HandUp Ministry is scheduled for September 10 and will draw tourists to Trenton. George made a motion to allocate \$600 advertising support for the event. Harry Abell seconded, and all board directors present approved.

As we anticipate receiving more requests in the future for advertising dollars for tourism promotion, we will develop a set of guidelines to help us consider each request.

Wayfinding Signs. The "Visitor Welcome Center" signs with directional arrows that were installed about a year ago have not held up. George contacted the Georgia State Prison system sign shop for highway-standard signs and received a quote of \$1436 for 13 new signs. George made a motion to approve the purchase. Harry Abell seconded, and all board directors present approved.

OPEN FLOOR

Light Up Trenton. The Light Up Trenton Committee – Jane Dixon, Kathleen Reed, Dena Abell and Carey Anderson – is emphasizing "Windows & Lights" this year. They will be asking Trenton businesses to create themed window paintings in addition to lots of lights. They will start with an email to the entire Alliance distribution list asking everyone to support upcoming events – Trick or Treat Alley, the Christmas Parade, Light Up Trenton, and DADE EXPO-Jolly Holidays! A second email will be sent to all businesses on the Light Up Trenton route, urging them to participate, and offering a suggestion to have Keeley Farmer paint their windows.

Alliance Live! Kathleen Reed said that after hearing that some people were reluctant to participate in a video because the name implies that it is, in fact, "live", she suggested that we change the name to "Alliance Investor Spotlight" or simply "Alliance Spotlight". She made a motion that we make that change. Harry Abell seconded, and all board directors present approved.

At 7:01 pm, Harry Abell made a motion, and Kathleen seconded, that we move to Executive Session to discuss personnel matters. Sue Gridley left the meeting and only board directors remained.
